

**Polk County Board of County Commissioners
Announces
Notice of Estimated Funding Availability and
Notice of First Public Meeting with a
Request for Public Comment Concerning the
Estimated Funding for 2022-2023 Federal Fiscal Year**

A virtual public meeting using a Zoom meeting format will be held Monday, February 21, 2022 at 4:00 p.m. The meeting will discuss programs funded by the United States Department of Housing and Urban Development (HUD). These programs support the goals of providing a suitable living environment, decent housing, and expanding economic opportunities for low- and moderate-income persons. HUD regulations require Polk County to prepare an annual 2022-2023 One Year Action Plan describing how this year's expected funding will be used to further the goals of the Five-Year Consolidated Plan. Polk County anticipates receiving funding allocations for:

- (Estimated) Community Development Block Grant (CDBG)
- (Estimated) Emergency Solutions Grant (ESG)
- (Estimated) HOME Investment Partnership Program (HOME)
