POLK COUNTY AT A GLANCE

Recovery throughout the nation continues and in Florida, Polk County is leading the way. Unemployment is recovering, sitting at 4.9% as of October 2021. Taking a more long-term view of the economic growth, Polk County saw significant private sector employment growth from Q1 2017 through Q1 2021, adding nearly 28,000 jobs (14.9% growth) during the period. The difference in growth between the nation and county accounted for more than 30,000 jobs locally. Our strongest-performing industries over the past two years have been the Trade, Transportation and Utilities Industry, the Information Industry, and the Financial Activities Industry. Wages have also improved overall, with 8.8% growth.

Looking forward, we should expect additional job gains in the most impacted industries to slow, both due to labor market supply issues and the rippling impacts of supply chain shortages. While Florida has committed to increasing the minimum wage to \$15/hour over the next five years, current indications from the labor market suggest that wage growth and demands may outpace that rate for businesses to return to pre-pandemic levels of employment. Returning to a “normal” economy continues, and Polk County’s business-friendly environment, ready workforce and connectivity further propel our community resilience.

POPULATION

Polk County outpaced the state and nation in population growth between the 2010 Census and the 2020 Census, growing 20.4% as compared to 14.5% and 7.3% for the state and nation, respectively. Within the larger cities (populations greater than 5,000), growth is being led by Davenport, Haines City, Lake Alfred and Winter Haven, all with between 30% growth or more over the 10 year period.



AGE

The county's age distribution reflects a larger portion of younger people (22.0%, under 18) than the state (19.7%) and a larger population of older people (20.4%, 65 and over) than the nation (16.5%). Both Florida (20.9%) and Polk County have an aging population. That said, the Polk County labor force grew by just under 15,000 people in the last year.

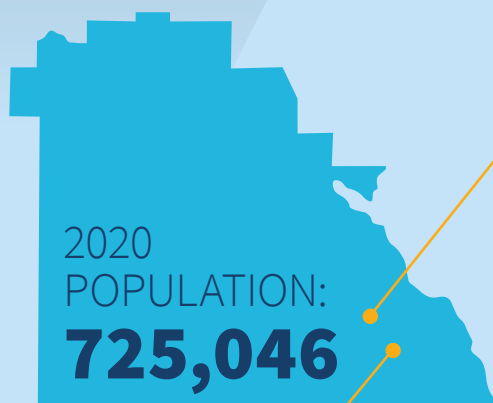


HOUSEHOLD

Polk County continues to have higher than average homeowner occupancy (68.9%, 65.4% and 64.0% for the county, state and nation, respectively) and lower than average costs for both homeowners and renters. While prices have risen considerably in the last year (+23%), the growth is in line with surrounding areas and the county remains relatively affordable.

Polk County has also seen meaningful growth in taxable property values, with total value increasing from \$40.0B in 2020 to \$43.6B in 2021, with over \$1.6B of that attributable to new construction. While the largest dollar value growth comes from Lakeland, the largest percentage growth comes from Davenport (26.3%) and Haines City (18.0%). Davenport's taxable value has more than doubled since 2018.

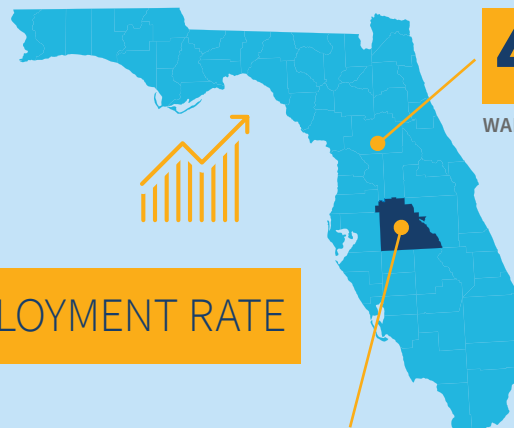

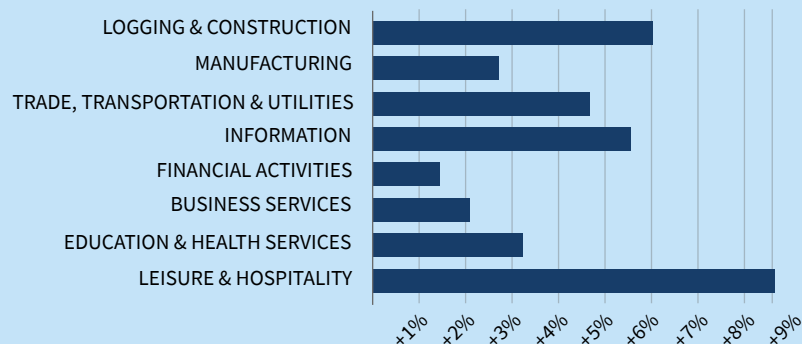

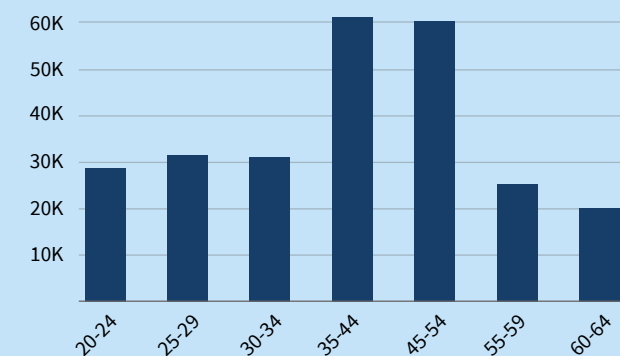
