Alain mentioned that during the last CRA Advisory Committee meeting on March 2<sup>nd</sup>, 2020, the Committee approved the Senior Art Program, however due to Covid-19 this program was not realized. Discussion ensued.

#### Soccer Field Discussion

Alain discussed that there was mention of previous discussions regarding using CRA funds to build a soccer field. Discussion ensued about its possible location and concerns.

#### Brick Pavers Discussion

Alain notified the Committee that the Brick Pavers Project had not transpired, and that it seemed like the project did not go past the discussion stage.

# • Financial Report

Alain updated the Committee on the expenditures made during fiscal year 2020-2021 and informed them of the current fund balance. The Committee was made aware of the Legislation passed by the State in 2019 that impacted CRAs. Deputy County Attorney, Elizabeth, gave an overview of the changes, and mentioned how they may affect what projects may or may not be allowed going forward. Additional discussion ensued.

#### 2021 CRA Projects

Committee Member, Lee Castillo, discussed the possibility of building a bus shelter for the bus stop located on the north bound side of US Hwy 17, and 3<sup>rd</sup> Avenue. Discussion ensued. The Committee gave Alain direction to research further.

Committee Member, Lee Castillo, discussed the issue with homes that collect debris, but may have difficulties with being able to haul the debris away. Lee asked about the possibility of a program to help residents with removal. Discussion ensued. Lisa went on to discuss some options, as well as introduce herself as the Code Investigator assigned to the Eloise area. Lisa and Alain were given direction from the Committee to research options. Deputy Owens was asked about the possibility of using Weekend Work Release Crews.

Lisa discussed current Codes related affairs.

Committee Member, Lee Castillo, discussed the possibility of having High Intensity Flashing Crosswalk Signage installed on 3<sup>rd</sup> Street. Discussion ensued. Direction was given for Alain to research further.

Committee Member, Lee Castillo, discussed about a previous request to look into installing Speed Calming Humps on 5<sup>th</sup> Street and 7<sup>th</sup> Street. Alain mentioned that a traffic stop had been conducted, but he did not have the results with him. Direction was given for Alain to report the findings of the study, and to look into the possibility of another traffic study.

Discussion took place with the Committee Members requesting ideas that may be allowable for the CRA. Elizabeth reiterated that any projects need to align with the CRA Plan.

Discussion took place regarding the vacancy on the Committee due to Mr. Powell's untimely passing, as well as Ms. Gil's upcoming end of term.
