## No. 4 on Agenda: Old Business

- Update: Information Requested for Possible Projects
  - Snively Brooks Park Restoration Projects:
    - Restoration of restrooms on park grounds
    - Soccer Field
    - Re-paving of Walking Path
    - Replacement of Walking Path Exercise Equipment
    - Volleyball Field
- Approval of Snively Brooks Park Restoration Projects
  - 1. Install Soccer Field, Bahia Sod, No Irrigation
  - 2. Refurbish Restrooms
  - 3. Replace Walking Path Exercise Equipment
  - 4. Install Volleyball Court, Sand Surface
  - 5. Repave/Repair Basketball Court Surface and Hoops
    - Amount not to exceed \$ 182,912

Alain explained to the Advisory Board that County staff had recommended that the Snively Brooks Park Restoration Projects all be presented and approved as one project, rather than separate items. Alain presented the Advisory Board a breakdown of the estimates for the individual items to be done at the park and explained that the estimate had increased since last meeting in order to allow for the uncertainty of costs resulting from supply chain issues. He also explained that the County and the School District had a facility use agreement in place that would allow the County to perform the repairs and upgrades to the park. He added that the School District requested that the project be carried out during the summer months so as to interfere with the use of the park for students during the current school year.

Eugenia Barton made a motion to approve the recommendation of the expenses from the CRA Trust Fund to the CRA Board, for an amount not to exceed \$ 182,912, with a second Martha Paul. All Advisory Members approved.

Alain went on to explain that staff would begin to work on an agreement between the CRA and the County Parks Division to fund the project.

Advisory Committee requested that pictures be taken before and after to show the project's impact. Alain explained that he had already taken pictures of the park prior in order to work on getting the estimates.
