SECTION 1: The Board does hereby determine and state the rate of millage to be levied for the Polk County Stormwater MSTU of the County budget for the 2022-2023 fiscal year as 0.0970.

SECTION 2: The millage to be levied pursuant to this Resolution, Section 7, is a 8.87% increase over the rolled-back rate of 0.0891 mills, computed pursuant to Section 200.065(1), Florida Statutes.

WHEREAS, the Board of County Commissioners of Polk County, Florida finds it necessary as a requirement of law to establish the ad valorem millage rate to be levied by the County for the 2022-2023 fiscal year;

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Polk County, Florida in open session duly assembled pursuant to notice on September 19, 2022 that:

SECTION 1: This Board does hereby determine and state the rate of millage to be levied for the Board of County Commissioners for each fund of the County budget for the 2022-2023 fiscal year as follows:

SECTION 2: The millage to be levied pursuant to this Resolution, Section 1, is a 8.21% increase over the rolled-back rate of 6.1841 mills, computed pursuant to Section 200.065(1), Florida Statutes.

SECTION 3: The Board does hereby determine and state the rate of millage to be levied for the Polk County Parks MSTU of the County budget for the 2022-2023 fiscal year as 0.5450.

SECTION 4: The millage to be levied pursuant to this Resolution, Section 3, is a 8.80% increase over the rolled-back rate of 0.5009 mills, computed pursuant to Section 200.065(1), Florida Statutes.

SECTION 5: The Board does hereby determine and state the rate of millage to be levied for the Polk County Library MSTU of the County budget for the 2022-2023 fiscal year as 0.2046.

SECTION 6: The millage to be levied pursuant to this Resolution, Section 5, is a 8.83% increase over the rolled-back rate of 0.1880 mills, computed pursuant to Section 200.065(1), Florida Statutes.

SECTION 7: The Board does hereby determine and state the rate of millage to be levied for the Polk County Rancho Bonito MSTU of the County budget for the 2022-2023 fiscal year as 9.1272.

SECTION 8: The millage to be levied pursuant to this Resolution, Section 8 is a 3.5% increase over the rolled-back rate of 8.8187 mills, computed pursuant to Section 200.065(1), Florida Statutes.

WHEREAS, the Board of County Commissioners of Polk County, Florida finds it necessary as a requirement of law to adopt the Final Budget for the 2022-2023 fiscal year;

NOW, THEREFORE BE IT RESOLVED by the Board of County Commissioners of Polk County, Florida, in open session duly assembled pursuant to notice on September 19, 2022, that:

SECTION 1: The Board does hereby adopt the final budget for the Polk County Parks MSTU for fiscal year 2022-2023 totaling \$38,228,771, which is hereby filed with the Clerk.

SECTION 2: The Board does hereby adopt the final budget for the Polk County Library MSTU for fiscal year 2022-2023 totaling \$7,645,393, which is hereby filed with the Clerk.

SECTION 3: The Board does hereby adopt the final budget for the Polk County Rancho Bonito MSTU for fiscal year 2022-2023 totaling \$61,020, which is hereby filed with the Clerk.
