Scope of Work: Work includes, but is not limited to, sidewalk construction including erosion control, clearing and grubbing (including tree removal), excavation, embankment, gravity wall, ADA ramps and detectable warnings, signing and pavement markings and maintenance of traffic. This project is federally funded with assistance from the Florida Department of Transportation.

The construction cost estimate for the project is \$714,915.00 and the project has 160 days to final completion.

Qualification Requirements: The prime contractor or subcontractors shall be on the **Current List of FDOT Prequalified Contractors** in the following major work classes of work: Grading; Driveways; Sidewalk; Pavement Marking; Roadway Signing.

Prime contractor must have been in business under the same name or EIN number for a minimum of 3 years.

Bidders must possess a Polk County Local Business Tax Receipt (f/k/a Business License) in order to do business with the County. A copy of such license must be provided to the Procurement Division before award is made to the successful bidder.

Contractor shall submit a reference list of at least three (3) completed projects performed as the prime contractor, with similar in size and scope, within the last five (5) years that reflects similar work performed. The list shall include: the project description, project address, current contact person, telephone number, and e-mail address. References should be submitted with the Bid or must be submitted by the successful vendor within five (5) business days of request and before award.

Percentage of Work: The prime contractor shall perform a minimum of 51% of all work contained within the scope of work as outlined in the bid documents and special conditions, with the exception of signalization. This percentage of work requirement does not include the furnishing of materials or equipment in the construction, if not installed by the primary contractor.
