Polk County, a political subdivision of the State of Florida, is soliciting bids for the following: **BID #24-133, Polk County Sheriff's Office Ridge District Station at Poinciana.**

A **MANDATORY** pre-bid will be held Tuesday, January 23, 2024, at 2:00 p.m. in the Fire Rescue Station Training Room, located at 9500 Marigold Avenue, Poinciana, FL 34759. A MANDATORY site visit will immediately follow. An authorized representative or agent of the Bidder must be present at this meeting, as evidenced by their signature on the meeting's sign-in sheet, or the Bidder's Submittal will be considered non-responsive.

Bids must be submitted in a "sealed" parcel or may be submitted electronically. Bids will be publicly opened and read at 2:00 p.m. on receiving date.

Scope of Work: This project is to construct and install Polk County Sheriff's Office Ridge District Station at Poinciana which includes civil, electrical, fire protection, landscaping, mechanical, plumbing, structural and architectural. The construction cost estimate for the project is \$8,318,000.00.

Qualification Requirements: Contractor must be licensed in the State of Florida as Certified Building Contractor (CBC) or General Contractor (GC) and shall have experience in completing at least three similar projects within the past five years. The contract time for this project is a total of 397 calendar days from Notice to Proceed for final completion.
