

NOTICE OF INVITATION FOR BID

Polk County, a political subdivision of the State of Florida, is soliciting bids for the following: **BID #24-154, Polk County Emergency Operations Center Warehouse.**

A **MANDATORY** pre-bid will be held January 19, 2024, 11:00 a.m. in the Polk County Emergency Operations Center, located at 1890 Jim Keene Boulevard, Winter Haven, FL 33880. A MANDATORY site visit will immediately follow. An authorized representative or agent of the Bidder must be present at this meeting, as evidenced by their signature on the meeting's sign-in sheet, or the Bidder's Submittal will be considered non-responsive.

Bids must be submitted in a "sealed" parcel or may be submitted electronically. Bids will be publicly opened and read at 2:00 p.m. on receiving date.

Scope of Work: This project is to install and construct a 8,000 square-foot emergency management logistics warehouse facility to be used for storage of special needs shelter supplies and equipment at the Public Safety Complex. The construction cost estimate for the project is \$1,334,935.00.

Qualification Requirements: Contractor must be licensed in the State of Florida as Certified Building Contractor (CBC) or General Contractor (GC) and shall have experience in completing at least three similar projects within the past five years. The contract time for this project is a total of 240 calendar days from Notice to Proceed for final completion.
