Question 4: Is there an engineer estimate available either for annual or term of contract?

Answer 4: There is no estimate available to the amount of work anticipated under this RFP. The purpose of this RFP is for one or more contractors to deliver turn-key projects on an as-needed basis.

The amount encumbered over the last 12 months for planned and emergency work under the current contract is approximately \$14,780,000.
