Polk County, a political subdivision of the State of Florida, is soliciting bids for the following: **BID #24-352, Sheriff's Office Animal Control North & South Kennels – Roof Replacement.**

A **MANDATORY** pre-bid will be held Thursday, May 9, 2024, 10:00 a.m., meet in lobby at the Animal Control Office, located at 7115 DeCastro Road, Winter Haven, FL 33880. A **MANDATORY** site visit will immediately follow. An authorized representative or agent of the Bidder must be present at this meeting, as evidenced by their signature on the meeting's sign-in sheet, or the Bidder's Submittal will be considered non-responsive.

Bids must be submitted in a "sealed" parcel or may be submitted electronically. Bids will be publicly opened and read at 2:00 p.m. on receiving date.

**Scope of Work:** Provide all labor, material, permitting, supervision, and equipment required to retrofit-fit the existing roof systems with a new Duro Last roof system in accordance with plans and technical specification outlined in the bid documents. Public Construction Bond is required. The construction cost estimate for the project is \$400,000.00.

**Qualification Requirements:** Contractor must be licensed in the State of Florida as Certified Building Contractor (CBC), General Contractor (GC) or Roofing Contractor and shall have experience in completing at least three similar projects within the past five years. The contract time for this project is a total of 65 calendar days from Notice to Proceed for final completion.
