Polk County, a political subdivision of the State of Florida, is soliciting bids for the following: **BID #24-516, King Blvd. Drainage Improvement Project - ARP**

A **MANDATORY** pre-bid meeting will be held Wednesday, June 26, 2024, at 9:00 a.m. at the Polk County Roads and Drainage Main Office, located at 3000 Sheffield Road, Conference Room 102, Winter Haven, FL 33880.

An authorized representative or agent of the Bidder must be present at this meeting in person evidenced by their signature on the meeting's sign-in sheet. Attendance will be taken prior to the start and end of the meeting. If the Bidder does not sign-in or provide information before or after the meeting, the Bidder's submittal will be considered non-responsive.
