

SOLICITATION FOR CONTINUING SERVICES

Cremation Services

CS 24-507

INTRODUCTION:

Polk County, a political subdivision of the State of Florida, having legal authority under Florida Statutes to dispose of indigent or unclaimed bodies, is seeking Submittals from experienced and qualified companies for administration of Polk County's Indigent Cremation Program, and other services as described for a set payment rate.

All responsive, responsible Vendors whose Submittal meets the minimum qualifications and have provided all the forms/documentation required of this solicitation, will be placed on a Qualified Vendor List (QVL) for these services.

The estimated annual spend for these services, based upon prior annual fiscal year actuals, is \$188,042. This estimate is not a guarantee.

QUALIFICATIONS:

1. Vendor must have been in business under the same FEIN number for the past three (3) years. **Evidence should be included with the vendor's submittal or must be provided prior to being placed on the QVL.**
2. Vendor must be a licensed funeral director in the State of Florida and have an operating facility located within Polk County meeting the requirements of this submission. Applicant shall remain in good standing with Florida licensing authorities during the contract term and all extensions as defined by Florida Statutes 497.373.
 - i. **Evidence should be included with the vendor's submittal or must be provided prior to being placed on the QVL.**
3. Additional Licenses:
Vendor and subcontractors must hold all legally prescribed licenses, certificates and permits in accordance with Chapter 497, Florida Statutes. All licenses, certificates and permits must be maintained in good standing for the duration of the contract term and any extensions

thereof. Required licenses, certificates, and permits per Florida Statute 497 include, but are not limited to, the following:

- a) Incinerator facility utilized by Vendor for provision of the cremation services must be licensed as an incinerator facility.
 - **A copy of the license should be included with submittal or must be provided prior to being placed on the QVL.**
 - b) Vendor must designate in writing, either a supervising licensed funeral director or licensed direct disposer.
 - **Please identify either the licensed funeral director and/or the licensed direct disposer the vendor will use to perform the services.**
 - **Name/Entity**
 - **Address**
 - **Contact Person**
 - **Phone number and email address**
 - **A copy of the license should be included with submittal or must be provided prior to being placed on the QVL.**
 - c) Vendor must possess and provide documentation of current certification by the state of Florida, Department of Environmental Protection (FDEP) for proper operation of said incinerator facility. FDEP certification must be updated annually by submitting an updated certification identified below to Indigent Health Care.
 - **A copy of the Vendor's current FDEP certification should be included with the submittal or must be provided prior to being placed on the QVL.**
4. Vendor shall have all paperwork and secure the necessary permits and submit verification of all required permits with any invoice submitted by the Vendor.
 5. Vendor must have an office located within the boundaries of Polk County, Florida, and has conducted business from that location for the past 3 years. Verification will be performed on the State of Florida's Division of Corporations website.
 6. The Vendor shall have access to all facilities, furnishing and equipment necessary to fulfill the contract requirements.
 7. Vendor shall submit a listing identifying any subcontractor or facilities the vendor will be utilizing, other than their own facility, to perform the scope of

work outlined within this solicitation. The vendor shall update this information if any subcontractors or facilities are added or deleted during the term of this solicitation. Updates should be sent to Indigent Health Care.

a. For each subcontractor and/or facility listed, the Vendor must provide a copy of the appropriate licenses and or permits. This information should be included with the submittal or prior to being placed on the QVL.

b. A listing of all known subcontractors and facilities must be included with the submittal or prior to being placed on the QVL.

8. For purposes of the services required by this submission, the Vendor must be capable of providing:

a. 24-hour response, 7 days per week, to transport deceased human bodies which are unclaimed, and remains of those deceased individuals who were indigent or for which no known funeral pre-arrangements have been made.

b. Storing deceased human bodies in accordance with the State Florida regulations governing this service.

9. Provide a primary and secondary Vendor point of contact for this solicitation to include:

- Contact Name
- Phone Number
- Email Address

The Contact persons provided will be the primary and secondary contact for the County to call/communicate with any requests for service or levels of service provided during the term of the solicitation. If at any time this information changes the Vendor shall update the Indigent Health Care staff as soon as possible. The Indigent Health Care contact information will be given to the Vendor upon award.

This information should be included with the submittal or prior to being placed on the QVL.

10. Vendors must possess a Polk County Local Business Tax Receipt (f/k/a Business License) in order to do business with the County. **A copy of such**

license should be included with the submittal or prior to being placed on the QVL.

11. Vendors must register their company to do business with Polk County. If you have not already done so, registration will need to be completed prior to Award by the Procurement Division, A purchase order cannot be issued to a vendor until they are registered. SCOPE OF WORK

The Indigent Cremation Program provides final disposition in accordance with Florida Statutes for those decedents who have no family, or whose family members or any legally authorized person (as the term is defined in Florida Statutes, § 497.005(43)) other than a medical examiner or Polk County, have not claimed the remains of a decedent (any such remains are “unclaimed”), and those decedents who did not have sufficient funds and assets to pay the costs for private funeral arrangements (such decedents are deemed “indigent”). Based on historical data, it is anticipated that approximately three hundred fifty (350) claimed and unclaimed human remains will need processing for disposition each year. The majority of those are expected to be adult cremations, approximately three hundred forty (340), but will include approximately ten (10) stillborn or infant cremations. This amount may vary, and the successful vendor must be capable of providing all services described herein.

The applicant will provide all services, labor, materials, and equipment, including the follow items, necessary to cremate any deceased human body per the requirements of this submission:

- Removal and transport to the vendors facility for storage/cremation within the required timeframes
- Cardboard pre-cremation body containers
- Modest cremation container per Florida Statutes, § 497.005(24) (a-e), for delivery of cremains to a legally authorized person.
- Direct cremation
- Precautionary pouches or other carrying container required to store, preserve, and transport human remains as required per Florida Statutes, § 497.386, to include without limitation those required for decomposed or infectious bodies.
- Administrative and operating costs including all overhead pertaining to services, labor, transportation, due diligence in search for next-of-kin, storage of remains and cremains, precautionary

pouches, and any other related costs associated with fulfilling the State Statutes and County requirements.

SPECIFICATIONS

Services will include (but not be limited to):

1. Dispatch of appropriate personnel to the place of demise, such as a nursing home or private residence, within one and one-half (1.5) hours of receipt of the request for removal. Removals from the Medical Examiner's Office will be performed within twenty-four (24) hours of being notified by the Medical Examiner.

The Vendor will also be responsible for removals in the event of a death where the police are unable to determine if funeral pre-arrangements have already been made and where the Medical Examiner has declined jurisdiction. Vendor has the right to refuse if not in area of location of decedent.

2. Storage of the human remains in a refrigerated facility while a search for surviving relatives is conducted. Vendor must have and/or have access to adequate space for temporary refrigerated storage for the anticipated daily volume of un-embalmed bodies pending disposition.
3. Vendor will provide a written record to the County of all steps taken to locate surviving family by the funeral home and/or another entity, not limited to law enforcement, Medical Examiner's officer, nursing home, hospital, etc. An Exhaustion Letter signed by law enforcement, or an Abandonment Letter provided by the Medical Examiner or hospital may be used in lieu of vendor conducting a search. County will confirm that appropriate steps to locate relatives have been followed and decide if County will seek additional information before a decision can be made to authorize the Vendor's disposition of the decedent's remains.
4. Publish an obituary or notification in the local newspaper or searchable public website of all unclaimed decedents referred to the Vendor for cremation services.
5. If surviving relatives are located, Vendor shall secure authorization for disposition. Disposition shall not be performed until a legally authorized person gives written authorization for disposition. Vendor shall also determine whether the surviving family relatives are willing to pay the costs of disposition, or whether decedent had a life insurance policy or other assets to cover these costs. If the family requires financial assistance to pay the decedent's disposition costs, the Vendor will

ensure the Request for County Cremation form is completed, dated and signed. Vendor shall ensure the family requesting assistance is notified that the County may need additional information other than requested on the form before a decision can be made.

6. For instances where a surviving relative requests the cremation of a decedent's remains, but then is unable to be further reached, Vendor must send out two letters to the surviving relative(s) including a letter by the funeral home or direct disposer explaining actions the relative(s) must take, and the date the funeral home or direct disposer must receive all applicable documents and other supporting information to include without limitation a fully completed Request for County Cremation form (**Attachment "A"**). The Vendor shall provide such relative(s) a reasonable amount of time (but at least fourteen (14) days after the date the relatives(s) receive the letter(s)) to respond to each letter.
 - One letter shall be sent via the US Postal Service regular mail.
 - Second letter shall be sent via certified signature.

After the second letter response date has passed without Vendor's receipt of all documents and information needed to finally dispose of the decedent's remains, the Vendor will notify the County of its communications with the surviving relative(s), along with a chronological letter of tasks completed to show notification due diligence and other relevant information reasonably necessary for the County to make a decision for further appropriate steps regarding disposition of the remains.

7. If after conducting a thorough and proper search for surviving relatives as required in Section 3 above, and after at least a minimum of fourteen (14) days have elapsed since the decedent's obituary or notification was published as required in Section 4 above, the Vendor reasonably suspects a decedent has no surviving family, and no individual has contacted Vendor to serve as a legally authorized person who would provide authorization for the disposition of the decedent's remains, then the Vendor may request the County act as a legally authorized person for final disposition of the unclaimed remains. The Vendor's request must document all steps taken to locate the decedent's surviving relatives, the basis for its conclusion the decedent has no surviving family members, and that no others have requested to serve as a legally authorized person. The County will consider the request in accordance with its policies and procedures, and after confirming compliance with the same and that appropriate steps to locate relatives have been followed will authorize the Vendor's disposition of the decedent's remains.

8. A direct cremation shall be performed for deceased persons, determined to be eligible for the Indigent Cremation Program except for the following instances that require a burial of the decedent's remains:
 - a. A direct burial for (i) cases in which the Medical Examiner's Office has ordered a burial as the final disposition of the remains for forensic purposes, (ii) veterans, or (iii) where the decedent's family (or any legally authorized person) has provided evidence of the decedent's practice of or adherence to a religious belief which forbids the cremation of a decedent's remains. The County will coordinate and pay for these direct burial services if eligible separately from this Continuing Service.
 - b. Veterans: Vendor must verify whether the deceased was a veteran.
 - i. If a decedent was a veteran, the County will coordinate, pay for, and comply with the requirements of Florida Statutes, § 406.50(2), and follow the procedures stated in 38 Code of Federal Regulations § 38.620 relating to the disposition of unclaimed deceased veterans.
9. Private Pay Cases: If subsequently located and willing to pay for regular, non-indigent funeral services, any relative, fraternal order, or legally authorized person may elect to use the funeral home or direct disposer of his/her choice, even if not the Vendor. The Vendor shall release the body to the funeral home for services, and the Vendor shall seek reimbursement for any service already performed (i.e., removal, storage) from the person(s)/organization making the private arrangements. Should the Vendor be unable to collect their fee in this manner, they may submit an invoice to the County for reimbursement, but only after exhausting all attempts to recover this fee from the private parties. Vendor must wait thirty (30) days for the person/organization to make the payment before seeking reimbursement from the County. County will pay these expenses at the contracted rate. Vendor shall attach documentation to the invoice indicating attempts to collect these expenses. Vendor shall reimburse the County for any previous County expenditures in the event a Private Pay case occurs. Vendor shall not charge the County for shipping charges of cremains to out-of-state next of kin. This cost is the responsibility of the next of kin.

Disposition of Remains: Per 497 Florida Statutes:

- a. In County - when cremains are requested by legally authorized person residing in Polk County, Vendor will make cremains available for pick-up.
- b. Out of County – when cremains are requested by a legally authorized person residing outside of Polk County, the cost of postage and handling shall be the responsibility of the requesting party.
- c. Unclaimed – in instances where a cremation was properly authorized but cremains remain unclaimed for a period in excess of one hundred twenty (120) days, Vendor will dispose of the cremains in a dignified manner (scattering at sea or other legal and dignified manner respectful of the deceased and surviving family), in accordance with Florida Statutes 497.607.
- d. Container – cremated remains container will be a sift-proof or similar type container in good taste and meeting US Postal Service’s shipment requirements. The inner container must be sealed and placed inside a second, durable outer container.

10. The Vendor will be responsible for filing, with all appropriate agencies, all the required documentation pertaining to the services performed.

11. **Reporting and Invoicing:**

1. Vendor will complete the “Request for County Cremation” form (**Attachment “A”**) and submit to the Indigent Health Care section along with the following forms, if appropriate:
 - a. Authorization for cremation and disposition provided by Vendor.
 - b. Any supporting documentation that County requests for verification of services, including but not limited to, an Exhaustion Letter or Abandoned Letter.
2. County will provide application decision to Vendor.
 - a. If approved, Vendor shall submit invoice for services provided, W-9 form, permit, and Affidavit for Indigent Cremation form (**Attachment “B”**) by mail or fax within 30 days of the approval letter (date indicated within later).
 - If invoice is not received by the stated date, the application will be denied, and Vendor must resubmit.
 - b. The Vendor understands and agrees that the County may reject any invoice or reimbursement request which is not completed and in the proper format, or which is submitted to the County’s Indigent Cremation Program after the stated timeline unless Vendor receives written permission for an extension. Invoices must list the decedent’s name, dates services were provided, and an itemized list of the

charges (at the approved rate).

3. In accordance with Qualifications, Item 4, Vendor shall have all paperwork and secure the necessary permits and submit verification of all required permits with any invoice submitted by the Vendor.

SPECIAL REQUIREMENTS

FACILITIES AND PROFESSIONAL STAFF:

1. Vendor shall furnish and provide all cremation services under this submission in accordance with all Federal and State legal requirements and professional and industry standards and practices.
2. Per Florida Statute 497, the Vendor shall have sufficient qualified trained technicians using modern (as determined by the Department and the industry) equipment and techniques available to perform cremation and disposition services in a timely manner.
3. Vendor shall obtain and maintain "in good standing" and in accordance by law, all applicable licenses and permits, ordinances, and regulations necessary to perform the disposition services specified at its own expense.
4. Vendor shall furnish all vehicles necessary to perform disposition services in a timely manner. The Vendor shall maintain all vehicles utilized in performing disposition services in good mechanical condition.
5. Vendor shall not subcontract any services provided under this contract without providing the subcontractor's credentials, licenses, and/or permits to the County prior to utilizing subcontractor for services.
6. Vendor shall provide and utilize all approved safety devices and equipment and shall exercise all care and measures necessary to safeguard property and persons with respect to its performance under this contract. In instances where the Vendor believes an unsafe condition exists regarding services being performed under the contract, the Vendor must immediately notify the County's project manager and take appropriate mitigating action.
7. Vendor must dispose of any bio-hazardous waste products generated as a result of the provision of any of the goods or services required under this contract, in a legally prescribed manner and at no additional cost. A human incinerator facility (crematory) shall only receive dead bodies for cremation; the facility may not receive any other materials including, but not limited to, medical, hazardous, and bio-hazardous waste, for

purposes of disposal.

WHEN SERVICES ARE NEEDED

The entity contacting a funeral home or direct disposer that is on this solicitation's Qualified Vendor List to perform the services as outlined in this Solicitation for Continuing Services will do so based upon the proximity of the funeral home or direct disposer to the entity. Every attempt will be made to rotate the vendors called, yet that will be at the discretion of the entity.

Special Conditions

1. The period of performance for this Continuing Service Solicitation is through January 31, 2029 ("termination Date"). Unless a Vendor is otherwise terminated in accordance with General Information Item #11. If the County provides notice to the Vendor at least 30 days prior to the Termination Date that it has not put in place a new bid for the goods, then this Bid shall remain in effect on a month-to-month basis until terminated by written notice from the County Procurement Division to the Vendor, but not longer than four (4) months following the termination date.
2. Performance of Work: Portions of the work required under this solicitation may be performed by subcontractors. The vendor shall be fully responsible for all acts and omissions of their subcontractors and of persons directly or indirectly employed by them and of persons for those acts any of them may be liable to the same extent as if they were employed by the vendor. Any work performed by the awarded vendor or sub-contracted out must meet all regulated deadlines.
3. Any amendments to this solicitation, which includes, an increase/decrease in pricing, additions, deletions, or modifications to the solicitation will require the Procurement Director's (or designee) approval. All vendors will be required to acknowledge and approve all amendments to remain on the QVL.

4. The County may employ other vendors to perform the work or self-perform the work described. Vendors are not being employed as the exclusive vendor to perform any such services.

Vendor Instructions and General Information

Vendor Instructions:

To ensure acceptance of the solicitation, follow these instructions:

Solicitation documents must be delivered to the Procurement Division

1. **Execution of Submittal:** Submittal must contain an original signature of an authorized representative in the space provided on the Signature Acknowledgement form.
2. **County as Gatekeeper of Documents:** This document is issued by Polk County and as such shall be the sole distributor of all amendments (changes) to these documents. It is the responsibility of the vendor to determine issuance of documents directly with the Procurement Division. The County is not responsible for any solicitations issued through subscriber, publications, or other sources not connected with the County and the vendor should not rely on such sources for information regarding the solicitation.
3. **Taxes:** Vendors are responsible for the payment of any applicable taxes that are connected to the purchase of any materials or subcontractors used in the execution of the solicitation.
4. **Discounts:** Vendors may offer a cash discount for prompt payment.
5. **Mistakes:** Vendors are required to examine the specifications, delivery schedule, prices and all instructions pertaining to the requirements of this solicitation. Failure to do so will be at vendor's risk.
6. **Invoicing and Payment:** Vendor shall submit an invoice to the County at the prices contained herein. **An invoice shall be submitted to the appropriate User Division.** The vendor shall include the solicitation number and/or the purchase order number, date services were provided, and description of services provided on all invoices. By submitting an invoice, vendor's Project Manager or any authorized officer is attesting to the correctness and accuracy of all charges. Invoices will be processed for payment when approved by the appropriate Division's Project Manager or designee. The County's payment of an invoice shall not constitute evidence of the County's acceptance of the Vendors performance of the Service or the County's acceptance of any work.
7. **Conflict of Interest:** All vendors must disclose, with their submittal, the name of any officer, director or agent who is also an employee of the County or any of their agencies. Furthermore, all vendors must disclose the name of any County employee who owns, directly or indirectly, any interest of any amount in the vendor's firms or any of their branches. Qualified vendors for this solicitation shall be subject to the provisions of Chapter 112, Florida Statutes.
8. **Warranty:** Unless otherwise specified, the vendor agrees that the goods furnished under this solicitation shall be covered by the most favorable commercial warranty the vendor gives to any customer for comparable goods, and that the rights and

remedies provided herein are in addition to and do not limit any rights afforded to the County by any other provision of this solicitation.

9. **Liability:** The vendor shall hold and save the County, its officers, agents and employees harmless from liability of any kind in the performance of this solicitation and against claims by third parties resulting from the supplier's breach of contract or the supplier's negligence.
10. **Patents and Royalties:** The vendor, without exception, shall indemnify and save harmless the County and its employees from liability of any nature or kind, including cost and expenses for, or on account of, any copyrighted, patented, or non-patented invention, process or article manufactured or used in the performance of the solicitation, including its use by the County. If the vendor uses any design, device or material covered by letters, patent, or copyright, it is mutually agreed and understood without exception that the solicitation prices include all royalties or cost arising from the use of such design, device or material in any way involved in the work.
11. **Indemnification:** Vendor, to the extent permitted by law, shall indemnify, defend (by counsel reasonably acceptable to County), protect and hold the County, and its officers, employees and agents, harmless from and against any and all, claims, actions, causes of action, liabilities, penalties, forfeitures, damages, losses, and expenses whatsoever (including, without limitation, attorneys' fees, costs, and expenses incurred during negotiation, through litigation and all appeals therefrom) including, without limitation, those pertaining to the death of or injury to any person, or damage to any property, arising out of or resulting from (i) the failure of Vendor to comply with applicable laws, rules or regulations, (ii) the breach by Vendor of its obligations under any Agreement with the County entered into pursuant to this solicitation, (iii) any claim for trademark, patent, or copyright infringement arising out of the scope of Vendor's performance or nonperformance of the Agreement, or (iv) the negligent acts, errors or omissions, or intentional or willful misconduct, of Vendor, its professional associates, subcontractors, agents, and employees; provided, however, that Vendor shall not be obligated to defend or indemnify the County with respect to any such claims or damages arising out of the County's sole negligence. The obligations imposed by this Section shall survive the expiration or earlier termination of the Agreement.
12. **Public Entity:** The Vendor declares and warrants that neither the Vendor nor any of the Vendor's affiliates, as that term is defined in Section 287.133, Florida Statutes, are subject to the restrictions in Section 287.133, Florida Statutes, regarding the commission of a public entity crime. If during the term of this Agreement, the Vendor or any affiliate is convicted of a public entity crime or is otherwise prohibited from performing work for or transacting business with the County pursuant to Section 287.133, Florida Statutes, then the Vendor shall be in material default of this Agreement, and in such case, the County shall have the rights and remedies as provided herein.
13. **Submittals:** All submittals must be completed and submitted either by mail or submitted electronically by email or fax. The submittal(s) shall be submitted on the

forms provided by Polk County. All submittals are subject to the conditions herein; failure to comply will subject submittal to rejection.

14. **Prices, Terms and Payment:** See Fee Schedule.
15. **Safety Standards:** Unless otherwise stipulated in the solicitation, all manufactured items and fabricated assemblies shall comply with applicable requirements of Occupational Safety and Health Act (OSHA) and carry evidence of Underwriters Laboratories' Listings (UL).
16. **Packaging:** All containers shall be suitable for storage or shipment, and all prices should include standard commercial packaging.
17. **Meets Specifications:** It is understood and agreed that any item offered or shipped as a result of this solicitation shall be new (current model) unless otherwise specified in the specifications. The vendor represents that all equipment offered under this specification shall meet or exceed the minimum requirements specified. Vendor shall strictly adhere to delivery specifications.
18. **Silence of Specifications:** The apparent silence of this specification and any supplemental specifications to any details or the omission from same of any detailed description concerning any point shall be regarded as meaning that only the best commercial practices are to prevail and that only materials of first quality and correct type, size and design are to be used. All workmanship is to be first quality. All interpretations of these specifications shall be made upon the basis of this statement.
19. **Governmental Restrictions:** In the event that any governmental restrictions may be imposed which would necessitate alteration of the material, quality, workmanship or performance of the items offered on this solicitation prior to delivery, it shall be the responsibility of the supplier to notify the Procurement Division at once. Their letter shall indicate the specific regulation, which required an alteration. The County reserves the right to accept any such alteration, including any price adjustments, or to cancel the contract at no expense to the County.
20. **Toxic Substances: Notice of vendor(s) to provide to Polk County toxic substances (As listed in Chapter 442.106, Appendix "G" of the FS) if applicable.**
 - a. Chapter 442 of the FS states that manufacturers, importers, or distributors of any toxic substance shall prepare and provide each direct purchaser of such toxic substance with Material Safety Data Sheet(s), herein referred to as MSDS, which to the best of the manufacturer's, importer's, or distributor's knowledge, is current, accurate and complete based on information then reasonably available to the manufacturer, importer, or distributor. Upon notification of a new or revised MSDS the manufacturer, importer, or distributor, on a timely basis not to exceed three (3) months after notification, shall provide the County with the revised information as it becomes available to the manufacturer, importer, or distributor.
 - b. Failure to provide the MSDS, when applicable, shall be cause for rejection of submittal.

21. **Inspection, Acceptance and Title:** Inspection and acceptance will be at the designated facility unless otherwise indicated. Title and risk of loss or damage to all items shall be the responsibility of the contract supplier until accepted by the County, unless loss or damage results from negligence by the County.
22. **Samples:** Samples of items, when called for, must be furnished free of expense and may, upon request, be returned at the vendor's expense. Each individual sample must be labeled with vendor's name, manufacturer's brand name and number, solicitation number and item reference. Vendors request for return of samples shall be accompanied by instructions, which include shipping authorization and name of carrier, and must be received within ninety (90) days after submittal. If a request for return and instructions are not received within this time, the Procurement Division shall dispose of the samples.
23. **Code of Ethics:** If any vendor violates or is a party to a violation of the code of ethics of Polk County or the State of Florida, with respect to this solicitation, such vendor may be disqualified from performing the work described in this solicitation or from furnishing the goods or services for which the solicitation is submitted and shall be further disqualified from bidding on any future solicitations for work, goods, or services for the County.

General Information

1. Definitions:

- The term "County" means the Polk County, a political subdivision of the State of Florida, and its authorized designees, agents, or employees.
- The term "Contract" means this solicitation document, any and all Addenda or Amendment issued, and the Contractors submittal.
- The term "Vendor", "Contractor" means qualified vendor(s) who executes a contract with the County.

2. Award(s): As the best interest of the County may require, the right is reserved to place vendors on the QVL; to reject any submittal or waive any minor irregularities or technicalities in submittals received. In determining a responsive and responsible vendor, the following may be considered:

- Vendor's evaluation – quality of performance on previous projects.
- The ability, capacity, equipment, and skill of the vendor to fulfill the contract.
- Whether or not the vendor can fulfill the contract within the time specified, without delay or interference.
- The character, integrity, reputation, judgment, experience, and efficiency of the vendor.
- The previous and existing compliance by the vendor with laws and ordinances relating to the contract.

- The sufficiency of the financial resources to fulfill the contract to provide the goods and/or services.
 - The quality, availability and adaptability of the suppliers or contractual services to the particular use required.
 - The ability of the vendor to provide future maintenance and service, as required or needed.
 - The number and scope of conditions attached to the solicitation.
3. **Effective Date:** The date of issuance of a Notice to Commence by the County Procurement Division.
 4. **Prohibition Against Considering Vendor Interests:** In accordance with Section 287.05701, Florida Statutes, the County may not (i) request documentation of or consider a Vendor's social, political, or ideological interests when determining if the Vendor is a responsible vendor; or (ii) give preference to a Vendor based on the Vendor's social, political, or ideological interests.
 5. **Non-Conformance to Continuing Solicitations Conditions:** Services not delivered as per delivery date in solicitation and purchase order may result in vendor being found in default, in which event any and all re-procurement costs may be charged against the defaulting vendor. This non-conformance to solicitation conditions may result in immediate cancellation of the purchase order.
 6. **Assignment:** Any purchase order issued pursuant to this solicitation and the monies which may become due herein are not assignable except with the prior written approval of the Procurement Director.
 7. **Disputes:** In the event of any doubt or difference of opinion as to the methods provided herein, or the level of performance rendered, the decision of the user division director shall be final and binding on both parties.
 8. **Facilities:** The County reserves the right to request the inspection report performed by the State of Florida.
 9. **Placing of Orders:** Being placed on the QVL does not constitute an order. Before any services can be performed, the vendor must receive written or oral notification in accordance with the practices of the User Division.
 10. **Precedence:** Any requirement set forth in any section of the solicitation documents shall be binding as if called for by all sections. If there is a difference in the terms anywhere in this document, the most restrictive shall prevail.
 11. **Termination/Suspension:** The County may terminate the Contract resulting from this Solicitation at any time, in whole or in part, in accordance with and subject to the following:
 - a. The County may terminate the Contract for the County's convenience by delivering 30 days' prior written notice of termination to the Vendor.

- b. The County may terminate the Contract immediately if the User Division determines that the Contractor is in material default of its Contract obligations, has notified the Contractor of such default by delivering a Vendor Complaint Form to the Contractor specifically describing the basis of the complaint and the conditions of the Contractor's default, and ten (10) days have passed since the Contractor's receipt of the Vendor Complaint Form without all defaults as described therein having been fully corrected. Notwithstanding anything to the contrary contained herein, the County may terminate the Contract immediately, without notice or any opportunity to cure, if the services rendered for the Contract cause or threaten endangerment to public health, safety, or welfare.
- c. Upon receipt of any termination notice as described above, the Contractor shall:
- Immediately discontinue all work unless the County's notice directs otherwise, and
 - Deliver to the County any and all data, reports, summaries, and all other information and materials of any type or nature whatsoever, whether completed or in process, the Contractor may have accumulated or generated in the course of performing the work of the Contract.
- d. In the event this Solicitation and/or the resulting Contract is terminated due to the Contractor's material default which is not cured within the allotted time period as described above, the Procurement Director may also suspend or debar the Contractor in accordance with the Suspension and Debarment Section of the County Procurement Procedures Manual. The rights and remedies of the County provided for in this Section are in addition and supplemental to any and all other rights and remedies provided by law or under the Solicitation and/or the resulting Contract.
12. **Annual Appropriations:** The vendor acknowledges that the County, during any fiscal year, shall not expend money, incur any liability, or enter into any agreement which, by its terms, involves the expenditure of money in excess of the amounts budgeted or the reduction of revenues for those budgeted agreements that may be available for expenditure during such fiscal year. Any agreement, verbal or written, made in violation of this subsection is null and void, and no money may be paid on such agreement. Nothing herein contained shall prevent the making of agreements for a period exceeding one year, but any agreement so made shall be executory only for the value of the services to be rendered or agreed to be paid for in succeeding fiscal years. Accordingly, the County's performance and obligation to pay under this agreement is contingent upon annual appropriation.
13. **Price Increases/Decreases, Additions, Deletions, or Revisions** to this Continuing Solicitation for Services, will be issued in the form of an Amendment by the Procurement Division and will be posted on the County's website. All vendors on the QVL will be notified via email and will be required to acknowledge the Amendment and their consent thereto. Any Vendor on the QVL that does not return a signed Acknowledgement of the acceptance of the amendment terms and conditions will be removed from the QVL until such acknowledgement is accepted.

Increases will be reviewed with firms on the QVL. Vendors on the QVL should contact the Indigent Health Care Section to request an increase on an annual basis. Increases will be reviewed annually during the month of June, starting June 2025. All request for increases should be submitted, including justification/substantiation for the increase, by June 1 annually to be considered. The County will review the requests and notify vendors on the QVL of the new rate. There may be instances where an increase is warranted outside of annually and will be handled on a case-by-case basis.

14. **Uncontrollable Forces (Force Majeure):** Either party hereunder may be temporarily excused from performance if an Event of Force Majeure directly or indirectly causes its nonperformance. An “Event of Force Majeure” is defined as any event which results in the prevention or delay of performance by a party of its obligations under this Agreement and which is beyond the reasonable control of the nonperforming party. It includes, but is not limited to fire, flood, earthquakes, storms, lightning, epidemic, war, riot, civil disturbance, sabotage, and governmental actions. Neither party shall be excused from performance if non-performance is due to forces which are reasonably preventable, removable, or remediable and which the non-performing party could have, with the exercise of reasonable diligence, prevented, removed, or remedied prior to, during, or immediately after their occurrence. Within five (5) days after the occurrence of an Event of Force Majeure, the non-performing party shall deliver written notice to the other party describing the event in reasonably sufficient detail, along with proof of how the event has precluded the non-performing party from performing its obligations hereunder, and a good faith estimate as to the anticipated duration of the delay and the means and methods for correcting the delay. The non-performing party’s obligations, so far as those obligations are affected by the Event of Force Majeure, shall be temporarily suspended during, but no longer than, the continuance of the Event of Force Majeure and for a reasonable time thereafter as may be required for the non-performing party to return to normal business operations. If excused from performing any obligations under this Agreement due to the occurrence of an Event of Force Majeure, the non-performing party shall promptly, diligently, and in good faith take all reasonable action required for it to be able to commence or resume performance of its obligations under this Agreement. During any such time period, the non-performing party shall keep the other party duly notified of all such actions required for it to be able to commence or resume performance of its obligations under this Agreement.
15. **Unauthorized Alien(s):** The vendor agrees that unauthorized aliens shall not be employed nor utilized in the performance of the requirements of this solicitation. The County shall consider the employment or utilization of unauthorized aliens a violation of Section 274A(e) of the Immigration and Naturalization Act (8 U.S.C. 1324a). Such violation shall be cause for unilateral termination of this Agreement by the County. As part of the response to this solicitation, the qualified vendor will complete and submit the attached form “Affidavit Certification Immigration Laws.”
16. **Employment Eligibility Verification (E-Verify)**

A. Unless otherwise defined herein, terms used in this Section which are defined in Section 448.095, Florida Statutes, as may be amended from time to time, shall have the meaning ascribed in said statute.

B. Pursuant to Section 448.095(5), Florida Statutes, the vendor hereto, and any subcontractor thereof, must register with and use the E-Verify system to verify the work authorization status of all new employees of the vendor or subcontractor. The vendor acknowledges and agrees that (i) the County and the vendor may not enter into this Agreement, and the vendor may not enter into any subcontracts hereunder, unless each party to this Agreement, and each party to any subcontracts hereunder, registers with and uses the E-Verify system; and (ii) use of the U.S. Department of Homeland Security's E-Verify System and compliance with all other terms of this Certification and Section 448.095, Fla. Stat., is an express condition of this Agreement, and the County may treat a failure to comply as a material breach of this Agreement.

C. By entering into this Agreement, the vendor becomes obligated to comply with the provisions of Section 448.095, Fla. Stat., "Employment Eligibility," as amended from time to time. This includes but is not limited to utilization of the E-Verify System to verify the work authorization status of all newly hired employees, and requiring all subcontractors to provide an affidavit attesting that the subcontractor does not employ, contract with, or subcontract with, an unauthorized alien. The vendor shall maintain a copy of such affidavit for the duration of this Agreement. Failure to comply will lead to termination of this Agreement, or if a subcontractor knowingly violates the statute or Section 448.09(1), Fla. Stat., the subcontract must be terminated immediately. If this Agreement is terminated pursuant to Section 448.095, Fla. Stat., such termination is not a breach of contract and may not be considered as such. Any challenge to termination under this provision must be filed in the Tenth Judicial Circuit Court of Florida no later than 20 calendar days after the date of termination. If this Agreement is terminated for a violation of Section 448.095, Fla. Stat., by the vendor, the vendor may not be awarded a public contract for a period of 1 year after the date of termination. The vendor shall be liable for any additional costs incurred by the County as a result of the termination of this Agreement. Nothing in this Section shall be construed to allow intentional discrimination of any class protected by law.

17. **Attorney's Fees and Costs:** Each party shall be responsible for its own legal and attorney's fees, costs and expenses incurred in connection with any dispute or any litigation arising out of, or relating to this Agreement, including attorney's fees, costs and expenses incurred for any appellate or bankruptcy proceedings.

18. **Public Records Law.**

(a) The Vendor acknowledges the County's obligations under Article I, Section 24, of the Florida Constitution and under Chapter 119, Florida Statutes, to release public records to members of the public upon request and comply in the handling of the materials created under this Agreement. The Vendor further acknowledges that the constitutional and statutory provisions control over the terms of this Agreement. In

association with its performance pursuant to this Agreement, the Vendor shall not release or otherwise disclose the content of any documents or information that is specifically exempt from disclosure pursuant to all applicable laws.

(b) Without in any manner limiting the generality of the foregoing, to the extent applicable, the Vendor acknowledges its obligations to comply with Section 119.0701, Florida Statutes, with regard to public records, and shall:

(i) keep and maintain public records required by the County to perform the services required under this Agreement;

(ii) upon request from the County's Custodian of Public Records or his/her designee, provide the County with a copy of the requested records or allow the records to be inspected or copied within a reasonable time at a cost that does not exceed the cost provided in Chapter 119, Florida Statutes, or as otherwise provided by law;

(iii) ensure that public records that are exempt or confidential and exempt from public records disclosure requirements are not disclosed except as authorized by law for the duration of the term of this Agreement and following completion of this Agreement if the Vendor does not transfer the records to the County; and

(iv) upon completion of this Agreement, transfer, at no cost, to the County all public records in possession of the Vendor or keep and maintain public records required by the County to perform the service. If the Vendor transfers all public records to the County upon completion of this Agreement, the Vendor shall destroy any duplicate public records that are exempt or confidential and exempt from public records disclosure requirements. If the Vendor keeps and maintains public records upon completion of this Agreement, the Vendor shall meet all applicable requirements for retaining public records. All records stored electronically must be provided to the County, upon request from the County's Custodian of Public Records, in a format that is compatible with the information technology systems of the County.

19. Scrutinized Companies and Business Operations Certification; Termination.

A. Certification(s).

- (ii) The Vendor is found to have submitted a false certification to the County with respect to any of the matters set forth in subsection A(ii) above, or the Vendor is found to have been placed on the Scrutinized Companies with Activities in Sudan List, or the Scrutinized Companies with Activities in the Iran Petroleum Energy Sector List, or has been engaged in business operations in Cuba or Syria, and the value of the goods or services acquired under this Agreement are greater than or equal to One Million Dollars (\$1,000,000).

20. **No Construction Against Drafter:** The Parties acknowledge that this Agreement and all the terms and conditions contained herein have been fully reviewed and negotiated by the Parties. Accordingly, any rule of construction to the effect that ambiguities are to be resolved against the drafting party shall not apply in interpreting this Agreement.

Safety Requirements/Regulations

1.0 All Vendors are required to submit, with their Submittal, the Safety Requirements/Regulations form. Any questions regarding compliance with the safety requirements/regulations provision shall be directed to the County Safety Officer, Risk Management, at (863) 534-5267.

1.1 The Vendor is responsible for observing all OSHA regulations and shall self-inspect to ensure this is accomplished. The Vendor shall ensure that all personnel are properly trained and shall be able to provide documentation for their personnel that have attended training courses. Examples of such training courses are Hazard Communications, Traffic Work Zone Safety, Personal Protective Equipment, First Aid/CPR, Permit Required Confined Space, Lock out/Tag Out of Hazardous Energy. All Vendors are required to comply with OSHA Standards regardless of the number of employees they may have.

1.2 A County representative may periodically monitor work site safety. Should there be safety and/or health violations, classified as Serious, Willful or Criminal/Willful Violations, the County's representative may have the authority, but not the duty, to require the Vendor to correct the violation in an expeditious manner. Inspections shall be based on requirements contained in law. The definitions of serious, willful and criminal/willful violations are as follows:

Serious Violation: A serious violation shall be deemed to exist in a place of employment if there is a substantial probability that death or serious physical harm could result from a condition which exists, or from one or more practices, means, methods, operations, or processes which have been adopted or are in use, in such place of employment unless the employer did not, and could not, with the exercise of reasonable diligence, know of the presence of the violation.

Willful Violation: May exist where evidence shows that the employer committed an intentional and knowing violation of the Act.

Criminal/Willful Violation: A repeat violation of a previously cited willful violation.

Violation of Serious, Willful or Criminal violation may have the following consequences:

First violation: correction may be a verbal warning and the correction shall be done the same day. Written documentation may be maintained by the County.

Second violation: may result in work stoppage until the violation is corrected. The work stoppage shall not entitle the Vendor to additional contract time or compensation. Liquidated damages provision will remain in full force and effect.

Third violation: this may constitute a breach of contract for safety violations and may result in termination of the contract at the sole discretion of the County.

Note: The County Safety Officer may stop any job to ensure the safety of all concerned.

1.3 Should the work site be in a hazardous area, the County shall furnish the Vendor with information concerning hazards such as types or identification of known toxic

material, machine hazards, Material Safety Data Sheets, or any other information that would assist the Vendor in the planning of a safe work site.

1.4 The Vendor shall be aware that while working for the County, representatives from agencies such as the United States Department of Labor, Occupational Safety and Health Administration (OSHA), and the Division of Safety, State of Florida, are invitees and need not have warrants or permission to enter the work site. These agencies, as well as the County Safety Officer, enter at the pleasure of the County.

1.5 The Vendor shall designate a competent person of its organization whose duty shall be the prevention of accidents at the site. This person shall be the Vendor's superintendent unless otherwise designated in writing by the Vendor to the County. All communications to the superintendent shall be as binding as if given to the Vendor.

2. Pursuant to Section 448.095(5), Florida Statutes, the Contractor, and any subcontractor under the Contract, must register with and use the E-Verify system to verify the work authorization status of all new employees of the Contractor or subcontractor. The Contractor acknowledges and agrees that (i) the County and the Contractor may not enter into the Contract, and the Contractor may not enter into any subcontracts thereunder, unless each party to the Contract, and each party to any subcontracts thereunder, registers with and uses the E-Verify system; and (ii) use of the U.S. Department of Homeland Security's E-Verify System and compliance with all other terms of this Certification and Section 448.095, Fla. Stat., is an express condition of the Contract, and the County may treat a failure to comply as a material breach of the Contract.

3. By entering into the Contract, the Contractor becomes obligated to comply with the provisions of Section 448.095, Fla. Stat., "Employment Eligibility," as amended from time to time. This includes but is not limited to utilization of the E-Verify System to verify the work authorization status of all newly hired employees, and requiring all subcontractors to provide an affidavit attesting that the subcontractor does not employ, contract with, or subcontract with, an unauthorized alien. The Contractor shall maintain a copy of such affidavit for the duration of the Contract. Failure to comply will lead to termination of the Contract, or if a subcontractor knowingly violates the statute or Section 448.09(1), Fla. Stat., the subcontract must be terminated immediately. If the Contract is terminated pursuant to Section 448.095, Fla. Stat., such termination is not a breach of contract and may not be considered as such. Any challenge to termination under this provision must be filed in the Tenth Judicial Circuit Court of Florida no later than 20 calendar days after the date of termination. If the Contract is terminated for a violation of Section 448.095, Fla. Stat., by the Contractor, the Contractor may not be awarded a public contract for a period of 1 year after the date of termination. The Contractor shall be liable for any additional costs incurred by the County as a result of the termination of the Contract. Nothing in this Certification shall be construed to allow intentional discrimination of any class protected by law.
