Polk County, a political subdivision of the State of Florida, is soliciting bids for the following: **BID #24-623, STONEWOOD SUBDIVISION DRAINAGE IMPROVEMENT PROJECT - ARP**

A **MANDATORY** pre-bid meeting will be held Monday, August 26, 2024, 10:00 a.m. at the Polk County Roads and Drainage complex, located at 3000 Sheffield Rd., Conference Room 102, Winter Haven, FL 33880. An authorized representative or agent of the Bidder must be present at this meeting in person as evidenced by their signature on the meeting's sign-in sheet, or the Bidder's bid will be considered non-responsive.

Scope of Work: The work is to install underdrain systems to protect roadway infrastructure, reconstruction of existing pavement at the eastern portion of the subdivision and replacement of failing pipes at three locations within the subdivision.

Qualification Requirements: Licensed Underground Utility or General Contractor shall have experience in completing similar projects.
