Scope of Work:

Description: The project includes the construction of a new 40 FT Geosynthetic Reinforced Soil (GRS) Integrated Bridge System (IBS) single span over Rock Ridge Ditch along Rock Ridge Road, in Lakeland. The construction of immediate approaches to the bridge and improvements to the adjacent ditches and driveways. Existing utilities will be required to relocate and/or adjust as needed.

Location: From Bartow head North on Broadway Ave/US-98 N for 13 miles. Next, turn right on N Florida Ave/US 98 N for 10.9 miles. Finally, turn east onto Roch Ridge Road and go 0.8 miles. All distances are approximate.

Scope of Work: Work includes, but is not limited to, bridge construction, roadway construction including erosion control, clearing and grubbing, excavation, embankment, stabilization, curb, drainage, retaining walls, and maintenance of traffic.

Estimated construction cost is \$2,121,000.00 with 180 days until final completion.

Qualification Requirements:

The prime contractor or subcontractors shall be on the **Current List of FDOT Prequalified Contractors** in the following work classes: Minor Bridges; Drainage; Pavement Marking; Roadway; signing.

Contractor must have been in business under the same name or EIN number for a minimum of 3 years.

The Successful bidder must possess or purchase a Polk County Local Business Tax Receipt (f/k/a Business License) to do business with the County. A copy of such license or proof of purchase must be provided to the Procurement Division prior to award being made.

Contractor must provide 3 references from clients in which the bidder has successfully completed projects similar in scope as the prime bidder, within the past 5 years.

Percentage of Work: The prime contractor shall perform a minimum of 40% of all work contained within the scope of work as outlined in the bid documents and special conditions, with the exception of signalization. This percentage of work requirement does not include the furnishing of materials or equipment in the construction, if not installed by the primary contractor.

Liquidated Damages: Applicable liquidated damages are the amounts established in FDOT Specification 8-10.2 Amount of Liquidated Damages.
