Polk County, a political subdivision of the State of Florida, is soliciting bids for the following: **BID #26-030, NERUSA AWS Receiving Facility UFA Supply Well**

A **MANDATORY** pre-bid will be held Tuesday, November 4, 2025, at 10:00 a.m. in the Utilities Administration building conference room, located at 1011 Jim Keene Bld, Winter Haven, FL 33880. An authorized representative or agent of the Bidder must be present at this meeting, as evidenced by their signature on the meeting's sign-in sheet, or the Bidder's Submittal will be considered non-responsive.

Respondents must submit one (1) original copy of the bid submittal prior to 2:00 p.m. on the bid receiving date. Bids must be submitted in a "sealed" parcel or electronically through Polk County's secure website, Kiteworks. Bids will be publicly opened at 2:00 p.m. on receiving date.

Scope of Work: Furnish all labor, materials, supervision, and equipment necessary for the construction and development of one (1) upper Floridan aquifer (UFA) supplemental supply well capable of a flow rate of 1,520 gallons per minute (gpm) without causing excessive drawdown at the future site of the Polk County Utilities (PCU) NERUSA AWS Receiving Facility in accordance with plan sheets and project manual outlined in the bid documents.

The construction cost estimate for the project is \$1,817,250.00.

Qualification Requirements: Current State of Florida Well Drillers license and have performed at least 3 projects of similar size and scope services as the prime contractor within the past five (5) years.

Liquidated Damages will be assessed at \$1,500.00 per day.

The contract time for this project is a total of 210 calendar days from Notice to Proceed to reach Substantial Completion and an additional 30 days from Substantial Completion to Final Completion.
